What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THIS PROSPECT BELIEVED, MISTAKENLY, THAT SHE HAD SENT THREE DEPOSIT CHECKS TO FUND HER INTERNATIONAL ACCOUNT, WHEN IN FACT SCHWAB RECEIVED ONLY ONE CHECK, IN THE AMOUNT OF \$250.00, WHICH DID NOT MEET THE APPLICABLE \$10,000.00 MINIMUM BALANCE TO ESTABLISH AN INTERNATIONAL ACCOUNT AT SCHWAB. THE SOLE DEPOSIT CHECK THAT SCHWAB RECEIVED FROM THIS PROSPECT WAS RETURNED TO HER BY SCHWAB. FINALLY, WHILE THIS PROSPECT'S ACCOUNT WAS BRIEFLY OPENED ON 4/20/2015, SCHWAB CLOSED THE ACCOUNT AND TERMINATED THE RELATIONSHIP THE FOLLOWING DAY, AND AFTER HAVING REVIEWED THE PROSPECT'S FALSE ALLEGATIONS AND DETERMINING THAT THE FIRM HAD NO INTEREST IN DOING BUSINESS WITH HER.
