AS WE DISCUSSED THESE OPTIONS NUMEROUS TIMES, HE NEVER MADE A FINAL DECISION AS TO WHICH HE WANTED TO DO AND BECAUSE I DO NOT HAVE DISCRETION OVER THE ACCOUNTS, I CANNOT ACT WITH CONFIRMING WITH THE CLIENT. THOUGH HE SENT IN EMAILS THAT REQUESTED THAT WE LIQUIDATE THE ACCOUNT AT ONE POINT, IN OUR PHONE CONVERSATION, WHICH I AM REQUIRED TO HAVE, HE RESCINDED THE REQUEST AND WAS TO GET BACK TO ME REGARDING HIS FINAL DECISION FOR THE ACCOUNT. HE NEVER DID. THE COMPLAINT AMOUNT IS NOT BASED ON AN ACCOUNT BALANCE THAT WAS PREDETERMINED AS A SELL POINT OR ONE THAT IS BASED ON A DAY THAT WE DISCUSSED THE PORTFOLIO. IT WAS DETERMINED IN HINDSIGHT AND IS BASED ON HOW MUCH MONEY HE WOULD LIKE TO HAVE. DESPITE A NEGATIVE RETURN ON THE S AND P SINCE WE STARTED WORKING TOGETHER THIS ACCOUNT IS STILL WORTH MORE THAN WHEN THE ACCOUNT WAS TRANSFERRED IN.
