What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

EVEN THOUGH THIS COMPLAINT WAS SETTLED, I DENY THE ALLEGATIONS AS ALLEGED. THE STRUCTURED NOTES PURCHASED WERE CONSISTENT WITH CLAIMANT'S INVESTMENT OBJECTIVES AND RISK PROFILE AND PROVIDED THE POTENTIAL FOR CAPITAL APPRECIATION, WHICH WAS CONSISTENT WITH THE CLAIMANT'S STATED DESIRE FOR GROWTH INVESTMENTS IN THE ACCOUNT. I HAD REASONABLE GROUNDS TO BELIEVE THAT THIS INVESTMENT WAS CONSISTENT WITH CLAIMANT'S OBJECTIVES AND RISK PROFILES. THE PERFORMANCE FAILURE OF THE NOTES WAS A DIRECT RESULT OF THE FINANCIAL CRISIS AND CREDIT COLLAPSE OF 2008 AND WOULD NOT HAVE BECOME AN ISSUE EXCEPT FOR THE BANKRUPTCY OF A MAJOR BANKING INSTITUTION WHICH WAS UNPRECEDENTED IN HISTORY. FURTHERMORE, THIS SETTLEMENT DOES NOT REFLECT ANY ACKNOWLEDGEMENT OR ADMISSION OF ANY LIABILITY OR MISCONDUCT ON MY PART WHATSOEVER. UBS, WHICH DENIED ALL OF THE CLAIMS ASSERTED BY THE CUSTOMER, DID NOT ACKNOWLEDGE OR ADMIT ANY LIABILITY OR WRONGDOING AND RESOLVED THIS ISSUE STRICTLY TO AVOID THE POTENTIAL COST AND UNCERTAINTIES OF THE ARBITRATION FORUM. FINALLY, I DID NOT, NOR WAS I ASKED TO PERSONALLY CONTRIBUTE ANY AMOUNT TOWARDS THE SETTLEMENT OF THIS CASE.
