IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	FA Comment: The 4 clients were moved from Wealth Management (WM) to Advisory Services Team (AST) where they maintain the same managed portfolio by the same professional management team but at a lower advisory cost. This was in the client's best interest since they were not meeting with me, their Advisor, for 2 years, it saved them money, caused no loss or change in their portfolio, and there are no client complaints. AST charges lower fees because there is no dedicated Advisor. The client can request an Advisor and move back to WM. I moved these clients because I was unable to reach them for years. The AST option was explained in email and voicemail. I consulted with my branch manager within a

week of moving 2 clients if I should move them back to WM, which he responded "no, do not move them back." Two other clients had withdrawn their portfolios well below the WM minimum.
