What is included in a IAPD report?

Where did this information come from?

Broker Statement

This account was a very wealthy lawyer who wanted to invest in private placements and this customer met with the officers of the companies that issued the private placements directly. I inherited the account from another advisor who had serviced the account for years and I only serviced the account for a limited time. I met with the client and another advisor the customer had at another firm and the other advisor told the customer, as I had, that he should hold the investments. And, after the customer left our firm, he bought more of the same investments he was complaining about from his other advisor. The customer did not name me as a respondent in the arbitration and I did not contribute to, or have any part in, the settlement. I am told the firm settled to avoid the legal fees and other costs of arbitration.
