THE CUSTOMER STATED HE HAD OVER 50 YEARS OF INVESTMENT EXPERIENCE, HE HAD WORKED IN A FEW BROKERAGE FIRMS AND WAS ALWAYS INFORMED ABOUT THE MARKET AND THE NEWS. ON 9/17/08, PRIOR TO THE EXECUTION OF THE TRADE, THE CUSTOMER SENT AN E-MAIL REQUESTING INFORMATION ON BARCLAYS , BANK OF AMERICA AND WACHOVIA'S MARGIN RATES. THE CUSTOMER INQUIRED ABOUT USING MARGIN, AND I ADVISED THE CUSTOMER THAT IT WAS NOT A GOOD TIME TO GO INTO THE MARKET DUE TO ITS VOLATILITY. THE CUSTOMER DIRECTED THE ORDER TO PURCHASE 8,000 SHARES TO ME AND THE BRANCH MANAGER, AND HE LATER STATED HE WANTED TO BUY STOCK. THE CUSTOMER DID NOT INFORM THE BRANCH ABOUT THE MISTAKE FOR A MONTH, AND FIRST HE STATED THE CORRECT ORDER WAS 800 SHARES, THEN THE CUSTOMER STATED THE CORRECT ORDER WAS \$8,000 DOLLARS OF BARCLAYS. THE CUSTOMER WAS UNSURE OF HIS INSTRUCTION.
