IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: AMERIPRISE FINANCIAL SERVICES, INC.

Allegations: THIS IS A CLASS ACTION ALLEGING THAT AN AFSI ADVISOR, AND HIS FORMER DOMESTIC PARTNER, WRONGFULLY INDUCED A NOW DECEASED CLIENT TO SIGN A NEW TRUST IN 2008 (2008 TRUST). PLAINTIFFS ALLEGE THAT THE 2008 TRUST CHANGED THE BENEFICIARIES OF HIS \$3.25 MILLION ESTATE FROM 75 DIFFERENT NON-PROFIT ORGANIZATION AND PLAINTIFF MESSICK TO THE AFSI ADVISOR'S FORMER DOMESTIC PARTNER. PLAINTIFFS CAUSES OF ACTION INCLUDE FRAUD, ELDER ABUSE, AND UNJUST ENRICHMENT. PLAINTIFFS REQUEST THAT THE COURT ORDER THE 2008 TRUST NULL AND VOID; FOR RESTITUTION REQUIRING THAT DEFENDANTS RETURN ALL OF THE ASSETS DERIVED FROM THE 2008 TRUST; FOR AN ORDER REINSTATING THE PREVIOUS TRUST; AND FOR UNSPECIFIED DAMAGES AND PUNITIVE DAMAGES.
