What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

****UPDATE - THIS DISCLOSURE IS NO LONGER REPORTABLE ON THE CURRENT U4 BECAUSE IT WAS FILED MORE THAN 24 MONTHS AGO AND DID NOT SETTLE FOR \$15,000 OR MORE****I RECEIVED AN EMAIL ON SEPTEMBER 8TH FROM THE CHIEF FINANCIAL OFFICER FOR THE COMMUNITY FOUNDATION OF BROWARD STATING THAT THE TRUSTEE HAD PASSED AWAY (WITH A COPY OF THE DEATH CERT.) AND THAT HE WOULD BE IN TOUCH WITH ME SHORTLY. THAT IS THE LAST I HEARD FROM ANYONE AT THE COMMUNITY FOUNDATION OF BROWARD UNTIL OCTOBER 7TH.

ON OCTOBER 7TH I RECEIVED A CALL FROM THE CHIEF FINANCIAL OFFICER FOR THE COMMUNITY FOUNDATION OF BROWARD STATING THAT THEY RECEIVED THE SEPTEMBER STATEMENT FOR THE ACCOUNT AND WERE INQUIRING WHY THE POSITIONS HADN'T BEEN LIQUIDATED AND THE MONIES WIRED THEIR BANK PER HIS INSTRUCTIONS. HE CLAIMED THAT HE SENT ME THESE INSTRUCTIONS BY EMAIL ON SEPTEMBER 25TH. I ADVISED HIM THAT I DIDN'T RECEIVE COMMUNICATION BY EMAIL FROM HIM ON SEPTEMBER 25TH AND THAT EVEN IF I HAD RECEIVED THIS COMMUNICATION, I COULD NOT ACCEPT INSTRUCTIONS BY EMAIL. I WOULD HAVE CONTACTED THEM DIRECTLY TO CONFIRM THIS REQUEST. I PROCEEDED TO LIQUIDATE THE PORTFOLIO AND UPON SETTLEMENT THE MONIES WERE WIRED OUT OF RAYMOND JAMES. ON OCTOBER 21ST, I RECEIVED A CALL FROM THE CHIEF FINANCIAL OFFICER FOR THE COMMUNITY FOUNDATION OF BROWARD. HE STATED THAT SINCE THE ACCOUNT (ACCORDING TO HIS CALCULATIONS) DROPPED \$22,000 FROM SEPTEMBER 25TH TO OCTOBER 7TH HE WOULD LIKE RAYMOND JAMES TO MAKE UP THE DIFFERENCE. I REMINDED HIM THAT I NEVER RECEIVED HIS EMAIL REQUESTING THE LIQUIDATIONS AND THAT WE CANNOT ACCEPT ORDERS VIA EMAIL. THIS REQUEST/COMPLAINT WAS ALSO SENT IN WRITING.
