IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement All facts regarding the fund in the Command account were fully disclosed to the client over several meetings. In addition, the client not only signed, but also initialed line by line items on multiple forms that clearly state the information the client is saying he was unaware of. No promise of any type of return was ever given. The investment was used as a fixed income alternative, and the client's second investment of this type. With the client's knowledge and agreement, a spousal rider was not used on one of his two retirement accounts due to the large drop in guaranteed income. However, this was all part of an overall client approved plan that covered the client's spouse with a death benefit previously not available to her, spousal continuation in the second retirement account, a life insurance policy, and through other sources of income.
