### What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE CLIENT CLAIMS SHE EVENTUALLY HAD TO PAY \$5,000 IN TAXES ON THIS WITHDRAWAL.

**Broker Statement** THE IR INDICATED THAT HE MET WITH THE CLIENT AND HER SON, AND SINCE THE ACCOUNT HAD NOT TRANSFERRED INTO HIS OFFICE YET, WAS UNAWARE AT THAT TIME THAT THE ANNUITY WAS IN AN IRA. THE IR FOUND THAT THE VALUE OF THE ANNUITY WAS DOWN FROM THE



ORIGINAL VALUE, AND THE IR DID INDICATE TO THE CLIENT AND HER SON SHE MIGHT NOT OWE ANY TAXES UPON SURRENDERING THE ANNUITY, BUT THAT SHE SHOULD CONSULT WITH HER ACCOUNTANT FOR MORE INFORMATION ON THE TAX IMPLICATIONS OF THIS WITHDRAWAL. ACCORDING TO THE IR, THE CLIENT AND HER SON HAD ALREADY DECIDED PRIOR TO COMING TO HIS OFFICE THAT THEY WERE GOING TO WITHDRAW THESE FUNDS TO PAY OFF CLIENT'S CAR AND HOME MORTGAGE. BECAUSE CLIENT WOULD HAVE BEEN AWARE THAT THESE FUNDS WERE HELD IN AN IRA AND THE IR ADVISED CLIENT TO SEEK INPUT FROM HER ACCOUNTANT AS TO THE TAX IMPLICATIONS, CLIENT'S CLAIM WAS DENIED.
