What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

IN REVIEWING THE TRANSACTIONS, IT DOES NOT APPEAR THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT WERE OUTSIDE THE SCOPE OF THE INVESTMENT OBJECTIVES, AND BOTH THE CLIENT AND HEIRS MAY BENEFIT FROM THE TRANSACTIONS. IT IS OUR OPINION ALL TRANSACTIONS EFFECTED IN THE ACCOUNT WERE AUTHORIZED. HOWEVER, THE ACTUAL TAX LIABILITY MAY NOT HAVE BEEN VERIFIED BEFOREHAND, AND IT DOES NOT APPEAR THAT IT WAS SUGGESTED TO THE CLIENT TO CONSULT A TAX ADVISOR FOR ADVICE PRIOR TO THE TRANSACTIONS IN QUESTION OCCURRING. IN LIGHT OF THIS, THE FIRM MADE AN OFFER OF SETTLEMENT TO THE CLIENT IN THE AMOUNT OF \$4,000. THE CLIENT'S ATTORNEY AND THE FIRM ENGAGED IN SUBSEQUENT COUNTEROFFERS. THE FIRM EVENTUALLY RECEIVED CORRESPONDENCE FROM CLIENT'S ATTORNEY DATED JUNE 3, 2004, WHICH DECLINED THE FIRM'S FINAL OFFER OF \$5,000. THE FIRM CONSIDERS THIS MATTER CLOSED.
