### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

IT IS OUR UNDERSTANDING THE CLIENT HAS HAD A FOLLOW UP CONVERSATION WITH THE FA REGARDING THE INCOME RECEIVED FROM THE BONDS; IT IS OUR UNDERSTANDING THE BONDS ARE HELPING MEET HIS INCOME GOALS. WHILE WE UNDERSTAND THE CLIENT'S FRUSTRATION WITH THE VALUE OF THE BONDS, THE VALUE IS BASED ON CIRCUMSTANCES BEYOND OUR CONTROL AND MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. THE REQUEST TO CANCEL THE TRADES AND RETURN THE AMOUNT INVESTED IN THE BONDS IS RESPECTFULLY DENIED. IF THE CLIENT WOULD LIKE TO LIQUIDATE THE BONDS, THE BONDS CAN BE LIQUIDATED AT THE CURRENT MARKET PRICE.
