IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: 11/14/2007-02/23/2009; THE CLIENT STATES HE INFORMED THE FA HE HAD A LOW RISK TOLERANCE AND HIS OBJECTIVE WAS NOT TO MAKE MONEY. THE CLIENT STATED HE WANTED A PLACE TO PUT HIS MONEY UNTIL HE WAS READY TO WITHDRAW IT. THE CLIENT STATES THE FA INFORMED HIM A TEAM OF NINE SPECIALISTS WOULD BE MONITORING HIS ACCOUNT AND ASSURED NO INAPPROPRIATE ACTIONS WERE TAKEN WITH HIS MONEY. THE CLIENT STATES HE CONTACTED THE FA AS THE MARKET DECLINED. HE STATES THE FA INFORMED HIM HE WAS INVESTED IN "STAPLE" PRODUCTS THAT WERE DOWN, BUT DOING OK. HE STATES THE ACCOUNTS WERE NOT MANAGED PROPERLY AND HIS REQUESTS ON WHAT TO DO WITH HIS MONEY WERE IGNORED. THE CLIENT STATES THE LOSSES HAVE CREATED A HARDSHIP. HE WOULD LIKE THE TRANSACTIONS REVIEWED AND COMPENSATION FOR HIS LOSSES.

Broker Statement

THE CLIENT'S COMPLETED RISK ASSESSMENT QUESTIONNAIRE DISCUSSES TRADING RANGES FOR THE VALUE OF THE PORTFOLIO IF IT WERE INITIALLY WORTH \$100,000, WHAT LEVEL YOU COULD ACCEPT THE RISK VERSUS THE REWARD. HIS RESPONSES INDICATE THAT HE COULD TOLERATE A FLUCTUATION OF THIS "PORTFOLIO" THAT FELL BETWEEN A VALUE OF \$91,000 AND \$117,000, FALLING INTO THE "LOWER RISK, LOWER RETURN" CATEGORY. HOWEVER, YOUR RESPONSES DO INDICATE SOME RISK WAS ACCEPTABLE, AND SOME RETURN WAS EXPECTED. HE MADE A STATEMENT TO THE EFFECT THAT NINE SPECIALISTS WERE MONITORING HIS MONEY. THE FA ACKNOWLEDGED THAT HE INFORMED THE CLIENT THE AMERICAN FUNDS EACH HAVE APPROXIMATELY FIVE TO NINE MONEY MANAGERS SUPERVISING EACH OF THEIR FUNDS TO ILLUSTRATE THEIR COMMITMENT TO MANAGING THE PORTFOLIO. THIS IS NOT, HOWEVER, TO BE CONSTRUED TO SUGGEST THAT NINE MANAGERS ARE MONITORING YOUR INDIVIDUAL ACCOUNT, BUT TO DEMONSTRATE THEIR DEDICATION TO MANAGING THE ENTIRE FUND DURING TOUGH TIMES. REGARDING THE DOW, THE FA EXPLAINED HE WAS ATTEMPTING TO MAKE THE POINT THAT THE DOW ONLY REPRESENTS 30 COMPANIES, AND MAY NOT ACCURATELY REFLECT YOUR PORTFOLIO WHICH HAS HUNDREDS SPREAD OUT OVER THE VARIOUS FUNDS YOU PURCHASED. THE MARKETS HAVE BEEN TO SAY THE LEAST, DISAPPOINTING, IN THE LAST YEAR OR TWO AND MOST PEOPLE'S PORTFOLIOS HAVE DIMINISHED DRAMATICALLY. THE FA SELECTED QUALITY, CONSERVATIVE INVESTMENTS FOR HIS RETIREMENT ACCOUNT WHICH SUITED YOUR NEEDS AT THAT TIME. WHILE YOUR ACCOUNT IS WORTH LESS THAN WAS ORIGINALLY INVESTED, PLEASE REMEMBER THAT A SUBSTANTIAL SUM WAS WITHDRAWN FROM THE ACCOUNT OVER TIME, THUS REDUCING THE FINAL BALANCE. THE CLIENT'S REQUEST FOR RESTITUTION IS DECLINED.
