IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement THE CLIENT HAD A MANAGED ACCOUNT WITH MORGAN STANLEY, AND ON FEBRUARY 5, 2006, HE COMPLETED TRANSFER PAPERWORK AT A RECEIVING FIRM WHICH WAS RECEIVED ELECTRONICALLY BY MORGAN STANLEY THE NEXT DAY. WE SET THE ACCOUNT TO TRANSFER OUT IN



KIND IMMEDIATELY BECAUSE IT WAS A MANAGED ACCOUNT FOR WHICH A REVOCATION OF POWER OF ATTORNEY WAS REQUIRED BEFORE THE ACCOUNT COULD BE LIQUIDATED. SUBSEQUENT TO FEBRUARY 6, THE CLIENT REQUESTED TO LIQUIDATE THE ACCOUNT BY CONTACTING HIS FINANCIAL ADVISOR, BUT THIS COULD NOT BE DONE BECAUSE THE IN KIND TRANSFER WAS ALREADY IN PROGRESS. HOWEVER IN, THE INTEREST OF CUSTOMER SERVICE, THE FIRM AGREED TO TRANSFER ALL POSITIONS BACK TO MORGAN STANLEY FOR LIQUIDATION. THE POSITIONS WERE NOT LIQUIDATED THE DAY THEY WERE RECEIVED AT MORGAN STANLEY AND AS A RESULT THE FIRM ADJUSTED THE ACTUAL LIQUIDATION DATE TO REFLECT THE FIRST DATE THAT WE COULD HAVE LIQUIDATED THE POSITIONS AFTER THEY WERE RECEIVED BACK.
