What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

In June 2016 an unknown and unauthorized third party accessed a customer's personal email account and impersonated her in an email to the advisor requesting a withdrawal of funds. Acting under the belief that the individual sending the emails was his customer, the advisor assisted in facilitating a withdrawal from the customer's account which was later determined to be a fraudulent request. The misappropriated funds were subsequently returned to the customer.
