IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

The false allegations by my ex-husband result from the recent termination of a very contentious divorce. All requests to transfer funds from my ex-husband's accounts were authorized by him and contemporaneously recorded in two signed verbal authorization forms as well as pursuant to an automatic funds transfer form executed by my ex-husband directing funds to a joint checking account at a local bank. At the time of account opening for each of his accounts, my ex-husband established online access with his personal email address and password, where he was sent notifications of each withdrawal, copies of statements and tax documents every year. The allegations are being made during the termination of our marriage and almost three years from the closing of the accounts by my ex-husband despite such prior notifications.
