**Allegations:** CLIENT ALLEGED THAT REGISTERED REPRESENTATIVE GAVE HIM INCOMPLETE OR MISLEADING INFORMATION WITH REGARD TO THREE STRUCTURED PRODUCT INVESTMENTS. FOR TWO OF THOSE INVESTMENTS, CLIENT ALLEGED THAT HE WAS NOT INFORMED THAT INTEREST WOULD NOT BE PAID IF THE PRICE WAS BELOW A BARRIER, THAT THE INVESTMENT DISCLOSURES WERE GIVEN TO HIM AFTER THE PURCHASE, AND THAT THE TERMS WERE ONLY EXPLAINED TO HIM AFTER HE ASKED REPRESENTATIVE WHY INTEREST PAYMENTS WERE NOT BEING PAID. THE CLIENT FURTHER ALLEGED THAT REGISTERED REPRESENTATIVE RECOMMENDED AN INVESTMENT IN CGMI MEDIUM TERM NOTES TO REDUCE RISK IN PORTFOLIO, AND THAT THE REGISTERED REPRESENTATIVE SAID IT WAS A LIQUID INVESTMENT. CLIENT ALLEGED THAT THE INVESTMENT IS NOW NEGATIVE, AND THAT THE DECLINE IS ASSOCIATED WITH CHARGES THAT HE WAS NOT INFORMED OF BEFORE INVESTING IN THE PRODUCT. OCCURRENCE DATES: 8/26/2014, 4/27/2015, 4/26/2017 TO PRESENT. ALLEGED DAMAGES: UNSPECIFIED
