**Allegations:** SON FOR CLIENTS CLAIMS IR, CHRIS CHAMBERS, RECOMMENDED THE LIQUIDATION OF MUTUAL FUNDS HELD BY HIS PARENTS AND THE PURCHASE OF AN ANNUITY. THE LIQUIDATION OF THE MUTUAL FUNDS CREATED A TAX PAYMENT OF APPROX. \$50,000. SON ALSO STATES HE DOES NOT BELIEVE THE ANNUITY WAS A SUITABLE INVESTMENT BASED ON HIS PARENTS AGE AND THE TAXES THE LIQUIDATION OF THE MUTUAL FUNDS CREATED. THE ANNUITY WAS CANCELLED IN A TIMELY MANNER, HOWEVER, THE SON IS REQUESTING HIS PARENTS BE PLACED BACK TO THEIR ORIGINAL FINANCIAL POSITION AS IF THESE TRANSACTIONS NEVER OCCURRED. IR STATED HE MET THE CLIENTS AT INVESTMENT CLASSES HE WAS OFFERING. IR STATED THE CLIENT INDICATED HE WAS PAYING TOO MUCH IN TAXES AND HAD INVESTMENTS LOSING VALUE. IR STATED THE CLIENT ALSO INFORMED HIM HE WAS PAYING \$3,500 IN QUARTERLY TAXES WHICH REQUIRED THE LIQUIDATION OF INVESTMENTS. IR STATED HE INFORMED THE CLIENT HE WOULD REVIEW THE STATEMENTS PROVIDED TO HIM; AT A LATER MEETING WITH CLIENT IR STATED HE PRESENTED THE PROTECTIVE ANNUITY, WITH A PROTECTIVE ASSOCIATE PRESENT. IR STATED HE PRESENTED ALL OF THE FEATURES OF THE ANNUITY, DISCUSSED CAPITAL GAINS AND SUGGESTED \$50,000 BE HELD BACK FOR THIS PURPOSE (ALTHOUGH IR DID NOT BELIEVE THE CAPITAL GAINS TAXES WOULD BE THIS HIGH). CLIENT INDICATED HE WISHED TO KEEP HIS VANGUARD FUNDS BUT LIQUIDATE ASSETS AT SCHWAB, T ROWE PRICE AND FRANKLIN TEMPLETON TO FUND THE ANNUITY. THE ANNUITY WAS PURCHASED AND THE CONTRACT DELIVERED. IR STATED HE BEGAN RECEIVING CALLS FROM THE SON, AND PROVIDED HIM WITH INFORMATION REGARDING THE FEATURES OF THE ANNUITY. IR STATED ON 10/23/01 HE SPOKE TO THE SON WHO INQUIRED ABOUT THE FREE-LOOK PROVISION AND REQUESTED THE ANNUITY BE CANCELLED UNDER SAID PROVISION. THE IR CONTACTED THE CLIENTS AND CONFIRMED THE INSTRUCTIONS TO CANCEL THE ANNUITY POLICY UNDER THE FREE-LOOK PROVISION. OUR RECORDS INDICATE THE ANNUITY WAS CANCELLED PURSUANT TO SAID PROVISIONS AS OF 10/26/01. IT APPEARS THE CLIENT UNDERSTOOD THE FEATURES OF THE ANNUITY AND THE PURCHASE WAS MADE PURSUANT TO DISCUSSIONS WITH THE IR AND WITH THE CLIENT'S AUTHORIZATION. IT ALSO APPEARS CAPITAL GAINS TAXES WERE TAKEN INTO CONSIDERATION. NO ADJUSTMENTS WILL BE MADE TO THE CLIENTS ACCOUNT.
