What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

My customer's beneficiaries were solicited by an attorney several years after my customer passed away. My customer had lost a modest amount of money in one of many investments which I recommended to him, which investment represented a very modest portion of the customer's overall assets. Notwithstanding overall success of the customer's portfolio, and specific acceptance and understanding of the risks of the particular investment at issue by the customer, the customer's heirs, long after the investment was made, and long after the estate was closed, signed on to participate in a mass claimant case with other investors in this particular product. There was no merit to the claim. It was brought by beneficiaries who had no involvement in my original interaction with the client. My broker-dealer settled this meritless claim for \$10,000 to avoid legal costs that would be greater, and I lost my opportunity to dispute this matter. I did not contribute a penny to the nuisance settlement.
