What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

The claim was closed/denied and found to be without merit. The client misinterpreted her JP Morgan account confirmation statement as being a complete summary of the total assets held in her account. The discrepancy (client's claim of loss in value) was a result of client mistaking a trade confirmation for a full account statement. Dollars client claimed to have lost were actually sitting in her separate JP Morgan Money Market Fund. These dollars would not have appeared on a trade confirmation, such as the one the client was reading.
