- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Broker Statement**

Merrill Lynch did not provide me with the complaint. My understanding is that it concerns withdrawals by the customer which invaded principal. Because the income from the accounts was variable, it sometimes was less than the customer's withdrawals. I discussed this with him as early as 2014, and the customer was aware of it and agreed to stay the course. He was set up on an automatic-withdrawal basis with all withdrawals going directly to his bank account. In a meeting in early 2018, the customer reaffirmed his satisfaction with how the account was being handled.
