What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

I VEHEMENTLY MAINTAIN THAT I, AS A JUNIOR INVESTMENT BANKING ASSOCIATE, ACTED PROFESSIONALLY, ETHICALLY AND WITHIN THE GUIDELINES OF OUR BROKER-DEALER'S POLICIES, OR FIRM'S POLICIES, AND FINRA'S POLICIES. THIS PARTICULAR ACCREDITED INVESTOR/CUSTOMER WASN'T EVEN SOLICITED DIRECTLY BY OUR FIRM/BROKER-DEALER. THE PLAINTIFFS' ORIGINAL SUIT WAS BROUGHT SOLELY AGAINST THE COMPANY THEY INVESTED IN, BUT THEY LATER DECIDED TO ADD A TOTAL OF 9 CODEFENDANTS, WE BELIEVE, IN AN ATTEMPT TO RECEIVE A BETTER CHANCE AT A SETTLEMENT.
