What is included in a IAPD report?

HE HAS HAD THE CONTRACT FOR MORE THAN 1 YEAR AND DID NOT REMEMBER THAT THE 5% REFERRED TO AN ANNUAL RETURN SHOWN IN THE HYPOTHETICAL PROPOSAL WHICH I SENT TO THE CLIENT BEFORE HE INVESTED. AFTER SPEAKING WITH THE CLIENT, HIS CONFUSION WAS CLARIFIED AND HE HAS NO ISSUE WITH THE PRODUCT. HE MADE NO CLAIM FOR DAMAGES AND HAD NO REALIZED LOSSES, NOR DID HE REQUEST TO SELL HIS INVESTMENT. HIS INVESTMENT VALUE ON THE DATE OF THE CLIENT'S E-MAIL ON 10-27-11 WAS \$95,656.18, WHICH WAS ONLY A DECLINE OF \$4,313.85 FROM ITS ORIGINAL INVESTMENT.
