CLIENT INVESTED \$200,000.00 INTO THE ANNUITY AND HAS WITHDRAWN APPROXIMATELY \$62,999.64. LINCOLN LIFE HAS INFORMED ME THE ABOVE-REFERENCED ANNUITY LOCKED IN AN ANNIVERSARY VALUE OF \$234,457.95 IN 2007 AND TAKING INTO ACCOUNT THE AMOUNT OF WITHDRAWALS, THE DEATH BENEFIT IS APPROXIMATELY \$173,194.92.
