IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CUSTOMER ALLEGES THAT THE REPRESENTATIVE MISLED HIM AND DID NOT PROPERLY EXPLAIN THE TERMS (WITHDRAWAL RATES AND DEATH BENEFITS) OF TWO VARIABLE ANNUITIES (VA). ONE VA WAS SOLD IN FEBRUARY 2011, THE OTHER IN SEPTEMBER 2013. AFTER THE INITIAL COMPLAINT WAS DENIED PARTLY DUE TO SIGNED PAPERWORK ON FILE, THE CUSTOMER AND HIS BENEFICIARY ALLEGED THAT NO PAPERWORK WAS GIVEN TO OR SIGNED BY THE CUSTOMER. THE FIRM RECEIVED A WRITTEN COMPLAINT WITH ALLEGATIONS REGARDING THE PAPERWORK, LACK OF SIGNATURES AND A DEMAND FOR \$120,041.
