CLIENT DELAYED IN GETTING DOCUMENTATION BACK TO ME. ONCE THE DOCUMENTATION WAS RETURNED, IT WAS INCOMPLETE. THAT DELAYED THE PROCESS EVEN LONGER. FINALLY, THE CLIENT RETURNED CORRECT PAPERWORK AND DOCUMENTATION. BY THIS TIME, THE MARKET HAD DROPPED CAUSING A GREATER LOSS IN THE ACCOUNT.
