What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

IT IS OUR UNDERSTANDING CLIENT CHOSE THE VARIABLE LIFE POLICY BECAUSE SHE PREFERRED TO INVEST IN THE MARKET (WITHIN THE VARIOUS SUB-ACCOUNTS) AND SHE BELIEVED THE COST WAS REASONABLE. FA HAS STATED CLIENT WAS CERTAINLY AWARE THIS WAS A VARIABLE POLICY AND HE EXPLAINED SHE MAY HAVE TO MAKE ADDITIONAL PREMIUM PAYMENTS IF THE MARKET DID NOT PERFORM AS ANTICIPATED. IN ADDITION, THE SUB-ACCOUNT INVESTMENT OPTIONS THAT WERE AVAILABLE TO THE CLIENT WERE OUTLINED ON THE NET PREMIUM ALLOCATION FORM (WHICH WAS SIGNED BY THE CLIENT ON 10/15/04). FA HAS STATED THE AMERICAN FUNDS INSURANCE SERIES SUB-ACCOUNTS WERE CHOSEN AS THE CLIENT WAS FAMILIAR WITH AMERICAN FUNDS WITHIN HER RETIREMENT ACCOUNT. BASED ON OUR REVIEW OF THE HARTFORD LIFE ILLUSTRATION SIGNED BY THE CLIENT ON 10/21/04, SHE ACKNOWLEDGED HER RECEIPT OF THE ILLUSTRATION AND PROSPECTUS AND ALSO CONFIRMED YOUR UNDERSTANDING OF THESE ITEMS. FURTHER, THE ILLUSTRATION REFLECTS PLANNED PREMIUM PAYMENTS FOR A MINIMUM OF TWENTY YEARS. WE RESPECTFULLY DENY CLIENT'S REQUEST TO MAKE ANY ADJUSTMENT TO THE ABOVE-REFERENCED LIFE INSURANCE POLICY.
