IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:	Invesco claims I emailed proprietary data to my personal computer. I have retained an attorney and we are cooperating with Invesco to give sufficient evidence that the items in question were deleted and no longer in my possession or PGIM's.
Product Type:	No Product
Broker Statement	I did not download, use or convey any client financial information. Upon notification of Invesco's concerns, I fully cooperated with Invesco. The investigation was concluded, and no action was taken. Until notified by Invesco, I did not understand that I had downloaded information that Invesco deemed proprietary as these were files I had either used, created, and/or edited while employed at Invesco, and did not contain any retail customer financial information. At the time the issue was raised, I was still employed by Invesco, but had given notice of my voluntary resignation and was serving out the term of my notice period. Upon being made aware of Invesco's concerns, I made available for Invesco's inspection all of my personal electronic devices, and cooperated fully with Invesco's investigation. No proprietary information was shared with Prudential Financial or any of its subsidiaries or affiliates. This was an internal employment issue only, and not a customer-related issue.
