**Broker Statement**

I completely deny these allegations and believe them to be totally false and inaccurate. The annuity was purchased to provide guaranteed income required to fund a long-term care policy. It was the client's responsibility to handle premium payments and ensure the policy would not lapse. The structured product investments were discussed and agreed to with the client as a way to reduce market risk. The client chose to liquidate them before maturity, despite them performing as designed. We worked with this client for a little over a year, and inherited the relationship from a retired advisor. The client was a sophisticated investor, with 20+ years of trading experience, and had purchased similar investments with the retired advisor for several years prior. Furthermore, upon a close review of the matter, UBS sent a formal response letter to the client on March 20, 2017, completely denying these false claims.
