What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: ON JANUARY 3, 2014, THE CUSTOMER SPOKE WITH DOUGLAS BOYD TO ESTABLISH AN IRA WITH VANGUARD AND INITIATE AN ASSET TRANSFER TO THE NEW ACCOUNT. THE CUSTOMER ALLEGES MR. BOYD CONFIRMED THAT UPON VANGUARD'S RECEIPT OF THE ASSETS ON JANUARY 28, 2014, HIS ASSETS WOULD BE INVESTED IN THE VANGUARD TOTAL STOCK MARKET ETF ("VTI"). INSTEAD THE ASSETS WERE PURCHASED IN THE VANGUARD PRIME MONEY MARKET FUND. THE PURCHASE OF VTI DID NOT OCCUR UNTIL THE CLIENT PLACED THE ORDER FOR VTI ON MARCH 20, 2014, WHICH RESULTED IN FEWER SHARES HAD THE TRADE BEEN PLACE AROUND THE TIME THE ASSETS WERE FIRST RECEIVED.
