What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE CLIENT PURCHASED THESE FUNDS IN EARLY AUGUST, 2001, AND THE TRADE CONFIRMATIONS WERE SENT TO HIS HOME WITH THE PROSPECTUSES. IN HIS LETTER, THE CLIENT STATES THAT HE WAS OUT OF TOWN, BUT REVIEWED THE CONFIRMATION ON AUGUST 10, WHEN HE RETURNED HOME. THE CLIENT DID NOT CORRESPOND WITH OUR DEPARTMENT UNTIL SIX WEEKS LATER (SEPTEMBER 24, 2001). THE CLAIM WAS DENIED.
