What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement I alerted LPL's Senior Investor Protection group of suspected financial exploitation



by a third party. After a preliminary review LPL's Senior Protection group made the determination to place restrictions on the clients account until a full investigation could be concluded. Both FINRA and the SEC require that LPL have policies in place to protect its customers, specifically in situations where there appears to be suspicious activity in an account. While we understand that this restriction may feel inconvenient, it is a necessary part of LPL's procedures.
