IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Employing firm when activities occurred which led to the complaint: CUNA Brokerage Services, Inc.

Allegations: Client had an existing non-qualified variable annuity with AXA Equitable. In early 2020, due to market volatility concerns the client decided to surrender the contract and conduct a 1035 exchange into a Principal Life Preferred Series fixed annuity. The forms were signed and sent for processing. During the carrier's processing time, the markets decreased, affecting the surrender amount of the contract. Unhappy with the transferred value, the client decided to 'free look' the new Principal fixed annuity due to the decreased amount. He is looking for reimbursement of the value due to the market decline.
