IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

REPRESENTATIVE BECAME THE CLIENT'S ADVISOR IN APRIL 2008. HE HAD ONGOING COMMUNICATION WITH THE CLIENT; ADVISED HER OF THE RISK ASSOCIATED WITH HER EXISTING EQUITY-HEAVY PORTFOLIO. THE CLIENT CLAIMED TO UNDERSTAND THE RISK ASSOCIATED WITH HER STRATEGY, INDICATING IT WAS NECESSARY IN ORDER TO ACHIEVE HER GOALS. AS THE STOCK MARKET DECLINED AT THE END OF 2008, THE CLIENT'S PORTFOLIO REFLECTED LOSSES IN LINE WITH RELEVANT BENCHMARKS. REVIEW OF CLAIMS INDICATES THAT CLIENT'S ACTUAL MARKET LOSSES WERE UNDER \$25,000, NOT THE \$100,000 ALLEGED. BASED ON REVIEW OF THIS CASE, ALL CLAIMS WERE DENIED IN THEIR ENTIRETY.
