IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THAT SHE DIDN'T WANT TO OWN INDIVIDUAL STOCKS, IR PRESENTED A DIVERSIFIED PORTFOLIO CONSISTING OF FIXED INCOME BONDS AND DIVERSIFIED GOVERNMENT, BOND AND GROWTH AND INCOME FUNDS. THESE PURCHASES WERE MADE IN JUNE 2002, AND THERE WERE NO COMPLAINTS ABOUT THE INVESTMENTS THAT WERE MADE IN HER ACCOUNT UNTIL THE MARKET DECLINED. CLIENT'S MUTUAL FUNDS DECLINED IN VALUE AND SHE NOW WANTS TO BE MADE WHOLE ON THOSE INVESTMENTS. THE CLIENT RECEIVED ALL TRADE CONFIRMATIONS AND CUSTOMER STATEMENTS DISCLOSING THESE TRANSACTIONS. THE MUTUAL FUNDS WERE SOLD OUT AT THE END OF SEPTEMBER 2002. IT WOULD APPEAR THAT THE CLIENT PURCHASED THESE INVESTMENTS AFTER IR DISCLOSED THEIR FEATURES, INCLUDING THE DIFFERENCES BETWEEN OWNING INDIVIDUAL STOCKS AND OWNING MUTUAL FUNDS. THE CLAIM WAS DENIED.
