What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

PEOPLE'S SECURITIES WAS NOT THE EMPLOYING BROKER AT THE TIME OF THE EVENTS ALLEGED, AND PEOPLE'S SECURITIES HAS NO ACCESS TO DOCUMENTARY RECORDS OR OTHER INVESTIGATIVE MATERIALS RELEVANT TO THIS PROCEEDING. HOWEVER, THE FIRM HAS DISCUSSED THE MATTER WITH THE RR AND REVIEWED THE ASSOCIATED CUSTOMER COMPLAINT U-4 DISCLOSURE FILING (#1543631 ON 01/07/2011). THE U-4 FILING BY THE PRIOR EMPLOYER, LINCOLN INVESTMENT, STATES IN SECTION 24 OF THAT "FIRM HAS ACKNOWLEDGED THAT THE TRADING DELAY WAS THE FIRM'S ERROR AND NOT THE REPS' ERROR AND THE FIRM IS REIMBURSING THE INVESTOR FOR TRADING LOSSES." APPARENTLY, THE CUSTOMER REJECTED LINCOLN INVESTMENT'S OFFER OF SETTLEMENT. IT IS PEOPLE'S SECURITIES POSITION, BASED ON THE INFORMATION ABOVE, THAT THE ARBITRATION CLAIM AGAINST THE RR IS WITHOUT MERIT.

THIS COMPLAINT WAS INITIATED AT THE RR'S PRIOR FIRM (LINCOLN INVESTMENT PLANNING). AS INDICATED IN THAT FIRM'S FILING, THE CIRCUMSTANCES LEADING TO THE DELAY IN TRADE PROCESSING WERE OUTSIDE THE CONTROL OF THE RR. DESPITE THIS, WHEN THE CLIENT FILED FOR ARBITRATION, THE RR'S CURRENT EMPLOYER (PEOPLE'S SECURITIES, INC.) REVIEWED THE FACTS AND CIRCUMSTANCES OF THE MATTER AND HAD MULTIPLE COMMUNICATIONS WITH THE CLAIMANT. THE PARTIES DETERMINED THAT IT WAS IN THE BEST INTERESTS OF ALL PARTIES TO SETTLE THE MATTER.
