#### Broker Statement

My identity was stolen in 2000. Someone took out a Providian Bank credit card in my name then defaulted on the card. In 2001, Providian sold the debt to a collection agency. The collection agency obtained a default judgment against me in 2007, but never served me properly so I had no idea that the judgment even existed. When I was finally alerted to the existence of the judgment, I went to NY Civil Court where I learned from a judge that the statute of limitations had run out on my ability to appeal the judgment. Apparently, I had a 2 year window to respond to the plaintiff from the time that the judgment was filed; and even though I was never properly served (and did not even discover this existed until almost 5 years after the fact) the court was not able to overturn the judgment. The judge recommended that I speak with an attorney about an appeal, which I did. The attorney told me that an appeal in NY Civil Court would cost \$10,000 and there was no guarantee of success, I could still owe over \$11,000 in principal and interest to the collection agency on top of the attorney fee. I negotiated with the debt collection agency to settle for \$3,500 and paid the settlement because it was the most cost effective route to take. Not only have I never defaulted on a credit card, I've never missed a payment. I settled this from a purely financial standpoint



only - the debt was never mine in the first place.
