What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

Broker Statement CLIENTS INVESTED 150,000 IN MAY 2013. THE APPROXIMATE VALUE AT THE TIME OF THE COMPLAINT WAS \$153,000. THE CLIENTS DID NOT LOSE 28,000, THE ACTUAL RETURN ON THE INVESTMENT WAS NET POSITIVE. I MET CLIENTS TWICE WITH PRIVATE BANKER. AT BOTH MEETINGS BEFORE INVESTING WE DISCUSSED INVESTMENT FIT, RISK TOLERANCE AND GOALS WITH THIS PORTION OF MONEY. THE CLIENTS WERE COMFORTABLE WITH THE RECOMMENDATION AND ALLOCATION. THE CLIENTS FORMULA FOR LOSS IS BASED ON OUTSIDE INVESTMENT THAT MADE 19 PERCENT, SO THEY FEEL THEY HAVE 28,000 LOSS, $150,000 \times 19 \text{ PERCENT} = 28,500$.
