Broker Statement IN MY ROLE WITH THE CLIENT, I WAS INITIALLY THE CLIENT'S PRIVATE BANKER. DUE TO A CHANGE IN OUR STRUCTURE, I BEGAN WORKING WITH



THE CLIENT'S INVESTMENT ACCOUNTS IN JANUARY 2007. AS A PRIVATE BANKER, I WAS RESPONSIBLE FOR THE OVERALL MANAGEMENT OF THE RELATIONSHIP AND FOR GENERALLY INTRODUCING OUR PLATFORM TO THE CLIENT. PRODUCT SPECIFIC CONVERSATIONS WERE AT THE TIME CONDUCTED BY A SEPARATE INVESTMENT SPECIALIST. WHEN THE ACCOUNT FIRST PURCHASED ARMS IN SEPTEMBER 2006, I WAS STILL IN THE PRIVATE BANKER ROLE AND THE INVESTMENT ACCOUNT WAS SERVICED BY ANOTHER REPRESENTATIVE.

PRIOR THE FEBRUARY 2008 ARMS MARKET FAILURES, THESE INVESTMENTS PERFORMED AS EXPECTED AND WERE AVAILABLE FOR REDEMPTION EVERY 7 OR 35 DAYS, DEPENDING ON THE RESPECTIVE ISSUES. SINCE FEBRUARY 2008, WE HAVE SUBMITTED 100% OF THE CLIENT'S ARMS FOR REDEMPTION AT EACH AVAILABLE AUCTION; FOUR OF THE ISSUES HAVE BEEN CALLED.

WHILE THE AUCTIONS HAVE BEEN FAILING, ALL OF THE ARMS HAVE PAID INTEREST AND THE INTEREST RATES HAVE BEEN RESETTING AT THEIR "PENALTY RATES." ADDITIONALLY, THERE IS A DIFFERENCE OF OPINION BETWEEN THE CO-EXECUTORS FOR THE ACCOUNT REGARDING THE BENEFIT OF THE ARMS HOLDINGS. SINCE WRITING THE FIRM, THE CO-EXECUTOR WHO COMPLAINED HAS INDICATED THAT HER COMPLAINT WAS AGAINST OUR FIRM, NOT AGAINST ME PERSONALLY, BECAUSE WE DID NOT RECOMMEND CLIENTS EXIT THE ARMS MARKET IN LATE 2007 PRIOR TO THE FAILED AUCTIONS HAPPENING IN 2008.
