What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

WRITTEN COMPLAINT FILED AGAINST OUR ADVISORY TEAM IN 2009. AFTER SIX MONTHS OF OWNING PARTICULAR INVESTMENT, AND MULTIPLE PORTFOLIO REVIEWS, CLIENT SUGGESTED THE INVESTMENT WAS NOT SUITABLE OR AUTHORIZED ONLY AFTER GLOBAL NEWS BROKE ABOUT [THIRD PARTY] PONZI SCHEME - WHICH ADVERSELY AFFECTED THE INVESTMENT VALUE AND LIQUIDITY. CLIENT AT THAT TIME REQUESTED PLACEMENT FEE BE REFUNDED, WHICH WAS OFFERED IN WRITING AND DECLINED ON MULTIPLE OCCASIONS. PLACEMENT FEE AMOUNT OF \$7,500 FELL WITHIN THE AGREED ANNUAL PERCENTAGE FEE CHARGED THE CLIENT. THE SUBJECT INVESTMENT AMOUNT, \$500,000, WAS 10% OF OVERALL INVESTED ACCOUNT VALUE WITH OUR ADVISORY TEAM. CLIENT ULTIMATELY HIRED LEGAL REPRESENTATION WHO FILED INACCURATE WRITTEN COMPLAINT SEEKING RETURN OF FULL INVESTMENT AMOUNT, WHICH WAS REVIEWED AND DENIED BY MORGAN STANLEY BASED ON FACTUAL EVIDENCE AND NOTES PROVIDED BY OUR TEAM. ONCE THE CLIENT'S REPRESENTATION RECEIVED WORD THAT THE REQUEST WAS BEING DECLINED, THEY PHONED MORGAN STANLEY LEGAL DEPARTMENT AND ASKED THAT THE REFUND OF THE PLACEMENT FEE AGAIN BE AVAILABLE FOR ACCEPTANCE. CLIENT THEN SIGNED OFF ON RETURN OF PLACEMENT FEE AND RETURNED REQUIRED DOCUMENTS 8 MONTHS LATER. COMPLAINT WAS ALSO REVIEWED BY FINRA WHO DETERMINED TO CLOSE THEIR INQUIRY SIGHTING LACK OF EVIDENTIARY
