IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations:	I WAS WORKING IN KANSAS CITY WHEN I WAS ADMITTED TO THE KANSAS BAR. IN JULY OF 1998 I LEFT THE TRADITIONAL PRACTICE OF LAW AND BEGAN TOWORK FOR A CONSULTING FIRM. BECAUSE I NO LONGER PRACTICED LAW AND DID NOT LIVE IN KANSAS CITY ANYMORE, I DICIDED TO NO LONGER PAY MY BAR DUES. I INFORMED THE KANSAS BAR IN JULY OF 1999 THAT I WAS NOT GOING TO PAY MY DUES BECAUSE I DID NOT FORE SEE A RETURN TO THE TRADITIONAL PRACTICE OF LAW. Sanction Details: I WAS SUSPENDED FROM THE PRACTICE OF LAW IN KANSAS FOR FAILURE TO PAY BAR DUES. THE ORDER INDICATES I CAN SEEK REINSTATMENT PUISUANT TO RULE 208(F)(3)

Broker Statement I INFORMED THE KANSAS BAR IN JULY 1999 THAT I WOULD NOT PAY MY DUES FOR THE YEAR BECAUSE I NO LONGER PRACTICED LAW AND NO LONGER PRACTICED IN KANSAS, I DID NOT FORESEE THIS CHANGING AND THEREFORE DID NOT FEEL IT WAS ADVANTAGEOUS TO CONTINUE MY MEMBERSHIP. I WAS INFORMED THAT IF I DID NOT PAY MY DUES, I WOULD BE SUSPENDED. I WAS FINE WITH THAT RESULT BECAUSE I COULD BE REINSTATED BY PAYING ALL BACK DUES AND COMPLETING CONTINUING LEGAL EDUCATION COURSES. I RECEIVED A LATE NOTICE IN AUGUST AND ONE IN SEPTEMBER ON NOBEMBER 4, 1999 THE SUPREME COURT OF KANSAS OFFICALLY SUSPENDED MY LICENSE TO PRACTICE LAW IN KANSAS. THAT IS THE LAST ACTION TAKEN AND MY CURRENT STATUS IN KANSAS.
