What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

The claim has been denied. Prior to the purchase of the two structured notes that are the subject of the complaint, customer had invested in other structured notes that had been profitable. Customer was aware of the potential benefits and risks of these investments. When the customer decided to terminate the relationship in September 2021, the representative offered to assist with selling the structured notes at issue, which would have been profitable at that time. As a result of global market events after the termination of the relationship, the notes declined in value and had sustained an investment loss at maturity in July 2022. This was more than 10 months after the customer had transferred her account to another firm, and more than 10 months after the representative had no role in the customer's investments.
