What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CLIENT STATES SHE TOLD IR SHE DID NOT WANT TO TRANSFER HER VARIABLE ANNUITY IF SHE HAD TO PAY SURRENDER FEES. CLIENT STATES IR LISTED HER NET WORTH ON HER ACCOUNT AS \$500,000, BUT HER NET WORTH IS ACTUALLY MUCH LOWER. CLIENT CLAIMS SHE LATER DISCOVERED THAT THERE WERE EIGHT YEARS OF SURRENDER CHARGES ASSOCIATED WITH HER ANNUITY. CLIENT FURTHER STATES SHE BROUGHT A CHECK INTO THE OFFICE FOR \$29,706.20 FOR THE IR TO PUT IN THE BRANCH SAFE. CLIENT CLAIMS IR INSTEAD DEPOSITED THE CHECK IN HER ACCOUNT AND INVESTED THE MONEY IN AN ANNUITY WITHOUT HER CONSENT. CLIENT ALSO STATES IR BOUGHT AND SOLD XCEL ENERGY STOCK WITHOUT HER KNOWLEDGE OR PERMISSION. CLIENT IS ASKING FOR \$1,959.45 FOR THE LOSS/COMMISSIONS PAID ON THE XCEL STOCK AND \$29,706.20 FOR THE CHECK THAT WAS INVESTED IN THE ANNUITY.
