IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	The case was completely frivolous and unfounded whereas the ex-client made



almost \$1,000,000 during his tenure with Sweetwater Financial. This is a fact to which both side agreed. However, the client effectively sought to recover an amount that represented the value from his "high water mark," less the value of his accounts when we left Sweetwater. It became increasingly clear throughout the information gathering process (prior to the arbitration date) that the ex-client and his counsel had no intention whatsoever to go through with arbitration - this appeared to be an attempt to legally extort from the insurance company. While both principals of Sweetwater Financial, as well as the insurance appointed attorney, wanted to go through with arbitration, the insurance company elected to settle with the ex-client for about 8% of his original demand. As part of the settlement agreement, the ex-client agreed not to challenge Sweetwater's and Mr. Teel's desire to have this complaint expunged from his records.
