What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

Where did this information come from?

Broker Statement

I BELIEVE THE COMPLAINT AGAINST ME IS EXTREMELY UNFAIR. AT CHARTER ONE BANK, I SOLD HUNDREDS OF ANNUITIES WITH A FIXED INTEREST RATE. MOST CLIENTS WANTED A MONTHLY OR QUARTERLY CHECK AUTOMATICALLY MAILED TO THEIR HOUSE. THE CLIENT IN QUESTION DID NOT WANT TO SET IT UP AUTOMATICALLY. THEREFORE, SHE WOULD COME IN PERIODICALLY TO SEE ME, AND I WOULD CALL THE ANNUITY COMPANY TO HAVE THEM MAIL A CHECK TO HER. THIS WENT ON FOR ALMOST 3 YEARS.

WHEN I LEFT CHARTER ONE SECURITIES ON 10/06 I WAS NOT ALLOWED TO CALL ANY CLIENTS. THE BANK POLICY IS THAT THEY WILL CONTACT ALL CLIENTS AND NOTIFY THEM THAT A NEW FINANCIAL ADVISOR WOULD TAKE OVER THE ACCOUNT. APPARENTLY THIS NEVER HAPPENED. THE CLIENT CAME INTO THE BANK TO SEE ME 3 MONTHS LATTER. I WAS NOT THERE. SHE PANICKED AND SOLD THE POLICY WHICH CAUSED A PENALTY OF \$5,000. A FEW MONTHS LATTER (6 MONTHS AFTER I LEFT THE JOB) I WAS NOTIFIED THAT THERE WAS A COMPLAINT FILED.

THIS OBVIOUSLY WAS NOT MY FAULT.
