What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations:	The Office of the Commissioner for the State of Wisconsin initially denied my insurance license application on November 1, 2023 based on a then pending lawsuit in Tulsa County, Oklahoma (CJ-2023-00865), which alleged, inter alia, breach of fiduciary duty and fraud related to the sale of a premium-financed life insurance policy. I strongly denied the allegations in CJ-2023-00865 and timely appealed the insurance license application denial decision on November 29, 2023. On June 9, 2024, CJ-2023- 00865 was resolved through a settlement with no admission of liability or wrongdoing on the part of any of the parties. On August 6, 2024, the Commissioner and I entered into a Stipulation and Order pursuant to which the Commissioner reversed the denial of my license application and granted me a non-resident Wisconsin individual intermediary insurance license effective August 6, 2024.

Broker Statement As described in item 7 above, the Office of the Commissioner for the State of Wisconsin initially denied my insurance license application on November 1, 2023 based on allegations (which I denied) made in a then pending lawsuit in Tulsa County, Oklahoma (CJ-2023-00865), which lawsuit was resolved through a settlement with no admission of liability or wrongdoing on the part of any of the parties on June 9, 2024. I timely appealed the denial of my insurance license application and on August 6, 2024, pursuant to a Stipulation and Order, the State of Wisconsin Commissioner of Insurance ultimately reversed the application denial and issued my non-resident Wisconsin individual intermediary insurance license.
