What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: CLIENT STATES HE PURCHASED A 50,000 FREDDIE NOTE ON JUNE 20, 2003 AT PAR FOR \$50,000. CLIENT STATES IR INFORMED HIM THAT, IF INTEREST RATES INCREASED, THE VALUE OF THE NOTE WOULD DECREASE. CLIENT STATES HE THOUGHT THE IR MEANT A DROP IN VALUE OF HUNDREDS OF DOLLARS, NOT THE THOUSANDS OF DOLLARS THAT THE BOND DROPPED. CLIENT STATES IR ENCOURAGED HIM TO HOLD THE NOTE, BUT CLIENT DECIDED TO SELL ON AUGUST 4, 2003 FOR A LOSS OF ALMOST \$8,000. CLIENT IS REQUESTING REIMBURSEMENT OF A PORTION OF THE LOSSES. LOSSES EXCEED \$5,000.

IR ALSO STATES THAT HE EXPLAINED THAT AS LONG AS THE CLIENT HELD THE BOND UNTIL CALL DATE OR MATURITY DATE, THE CLIENT WOULD RECEIVE THE PRINCIPAL AND WOULD HAVE RECEIVED THE INTEREST PAYMENTS. IT IS UNDERSTOOD THAT AFTER THE VALUE OF THE BOND BEGAN TO FLUCTUATE, THE CLIENT WAS ADVISED BY THE IR TO CONTINUE TO HOLD THE BOND, BUT THE CLIENT INSTRUCTED THE IR TO SELL. BASED ON OUR INVESTIGATION, WE HAVE NO REASON TO BELIEVE THIS SITUATION WAS NOT HANDLED APPROPRIATELY BY THE IR, AND THEREFORE, WE DENIED THE CLIENT'S REQUEST FOR COMPENSATION.
