To be clear, the adviser was not named as a party in this matter that was brought against his former firm. In expectation of retirement, the client specifically sought income-producing investments that were not correlated to the securities markets. At the time of purchase she received appropriate disclosures about the risks and liquidity of the investments. The client agreed that the investment was a suitable part of her portfolio given her other investments and cash reserves. Despite the underperformance of this one investment, her overall portfolio grew by nearly \$270,000.00 in 6 years.
