### Broker Statement

It's disappointing to me that this arbitration claim and award appears on my record. I always acted properly and in the best interests of this client, as I have done for all my clients throughout my two decades as a financial advisor. This client brought claims against my employer, not against me, alleging that the firm misrepresented the risks of a proprietary options overlay strategy. It appears on my record solely because FINRA requires the reporting of arbitration claims on the record of the claimant's broker of record -- even though in this case the arbitrators awarded the client only 5% of what he was seeking, which indicates that they disbelieved almost all of his claims against the firm. I was not a named party to the action, there was no award against me, I was not asked by my employer to contribute in any way to the award, and I have not been the subject of any disciplinary action by my employer or any regulator. I have an otherwise spotless record in the industry, and continue to have the privilege of serving many satisfied clients.
