What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

The capacity of hard drives needs to continue increasing to meet the demands of data growth. This team has developed unique to market aspects of HAMR "pronounced Hammer" (Heat-Assisted Magnetic Recording) alongside some of the most complex nanoscale recording technologies, enabling mass-capacity storage gains at unprecedented areal densities of 3TB/disk and beyond. HAMR requires a new media magnetic technology on each disk that allows data bits to become smaller and more densely packed than ever, while remaining magnetically and thermally stable.
